

draw.io EULA / Terms of Service

1. Introduction

Unless otherwise indicated, the draw.io application is the property of JGraph Ltd. The software and services provided by JGraph Ltd are at all times subject to these terms and conditions. By using draw.io you confirm your acceptance of, and agree to be bound by, these term and conditions. These terms and conditions shall constitute the agreement between you and JGraph Ltd ("this Agreement").

2. Agreement to Terms and Conditions

This Agreement takes effect on the date on which you first use the draw.io application.

3. License Duration

This license to use draw.io as a service hosted by JGraph is perpetual, with the exception of you breaking any part of this license, in which case you lose all rights under the license. If you use the draw.io source code to host draw.io yourself, you are bound by the software license under which you obtained the source code.

4. Disclaimer

It is not warranted that any software supplied by JGraph Ltd will meet your requirements or that its operation will be uninterrupted or error free. JGraph Ltd exclude and expressly disclaim all express and implied warranties or conditions not stated in this Agreement (including without limitation, loss of profits, loss or corruption of data, business interruption or loss of contracts), so far as such exclusion or disclaimer is permitted under the applicable law. This Agreement does not affect your statutory rights.

5. Warranties and Limitation of Liability

JGraph Ltd warrants that its software and services will be provided using reasonable care and skill on a non-exclusive basis. Where JGraph Ltd supplies any goods supplied by a third party, JGraph Ltd does not give any warranty, guarantee or other term as to their quality, fitness for purpose or otherwise, but shall, where possible, assign the benefit of any warranty, guarantee or indemnity given by the person supplying the goods to JGraph Ltd. draw.io is actively developed, evolving software. JGraph Ltd reserves the right to change any part of that functionality without giving prior notice to you. You agree that you will not engage in any activity that interferes with, or disrupts the draw.io service.

7. Notices and Consents

Any notice, request or other communication to either party by the other under this Agreement shall be given by email, fax or conventional mail and shall be confirmed by conventional mail.

8. Assignment of Rights

You shall not assign this Agreement or any benefits or interests arising under this Agreement without JGraph Ltd's prior written permission, such not to be unreasonably withheld.

9. Content

The ownership of marketing materials, any software or electronic media, methodologies, strategies, research and designs shall remain with JGraph Ltd. JGraph Ltd reserves the right to use in any way it wishes any programming tools, skills, content, methodologies, strategies and techniques acquired or used in performing its duties under this Agreement. The ownership of any data content created using the software shall remain with the author of that content. JGraph Ltd provides permission for vector and raster representations within the software that it owns to be combined with the representation that the author has created and for the combined result to be persisted in either vector and/or raster format. You may use such graphically persisted representation that you create for any purpose that does not interfere with the business operations of JGraph Ltd. You agree that you are solely responsible for (and that JGraph Ltd has no responsibility for any content you create) any Content that you create, transmit or display while using the service.

10. General Terms and Law
